1958 Public Speaking

a) Members of the public

Representatives of Safer discussed the latest meetings with DCC and the planning for Ecobat noting the desire to extend the parking, the slow production of liaison minutes which they have asked the DCC Scrutiny Committee to look at, hazardous substance consent and traffic movements.

b) PDNPA Parish Member Kath Potter, DCCIIr Sue Hobson, DDDCIIr Laura Mellstrom and PCSO Boswell sent apologies.

Inspector Booth and Sergeant Grant attended the meeting to inform us of the Safety Group plan for this year's Solstice and listen to concerns and were joined by James Adams DCC Highways who reiterated the scheme was the best case option whilst still a nuisance factor for residents, quarries and road users on the Stanton Lees side. The tree cutting on 24th was raised for a potential road closure clash if the weather is so good that there are still cars on Lees Road over the top and will be monitored by both to ensure emergency vehicles can safely pass. EMAS have finally deleted the closed Lees Road from their mapping system. The multi-agency on site meeting will be attended by our Chair.

James Adams joined a discussion on Utilities traffic management and leaving lights on when no work is being done in the highway plus breakdowns during those periods providing additional hazards. DCC is hamstrung by Central Government not giving weighting to powers for Highways Inspectors to challenge Utility bad practice in a meaningful way.

Council notes that this is work to an already existing rear lean-to extension and the stone coal shed outbuilding is already in situ, so effectively the only visible build will be a 'link' from

the main building to the existing stone outbuilding and the introduction of a Velux roof light to the front of the outbuilding. Providing the materials used in the connecting work are in keeping with the main stone work, Council supports this application.

ii) for Decision – NP/DDD//0424/0431 The Cottage Middle Street – Proposed Garden Room and Store (0432 – listed consent)

Council supports this providing neighbours are aware and planners have no problems with the increased height, and the air source heat pump has adequate sound proofing.
