Representatives of Safer discussed the next steps following the 150 plus responses from both this parish and South Darley. It was agreed that Safer need to present this in good time to Ecobat before the next ELG to enable questions and feedback to be asked by both parishes council representatives They plan to forward this information to South Darley for distribution to its members and attend their next meeting and will also be submitting it to the Environment Agency with a view to assisting Ecobat – one example being local noise and light monitoring feedback to help show where tree management and Site measures can best minimise the affect of this.

b) PCSO Boswell PDNPA Parish Member Kath Potter and DDDCllr Laura Mellstrom sent apologies

DCCIIr Sue Hobson noted the VAS system should by installed once flood warning software is added. The meeting requested that local parishes be issued with leaflets to state how the system works to ensure their Duty of Care in ensuring car users as well as HGVs know what the procedure is.

The road closed signs for the landslip have all faded out but only one has been renewed so far. A request from adjacent landowner was passed on to be informed of the plans for conversion to a bridlepath – especially as the ground is still moving. The Recycling centre requires Derbyshire residents to register their cars as number plate recognition is being used to ensure only domestic users use for free – a link will be put in Snail. The White Peak Trail is to receive funding to extend beyond Rowsley. DCCllr Hobson left the meeting at this point.
