2044 Public Speaking

a) Members of the public

The representative of Safer noted the success with their face-to-face meetings with the MD and the hope that these could be held in between the Liaison group to give more impetus to focusing results. Unfortunately the liaison meetings are being scheduled at times when the MD is unavailable currently and this needs addressing for loss of action by Ecobat. The Woodland plan was discussed in detail in light of the 2 hour public presentation prior to the next Liaison meeting.

First Period Review of Old Minerals Permission (ROMP) for the Determination of Conditions

Council would expect due consideration to be given to local needs for noise, dust and traffic if any works are permitted but is unaware of the local logistics for this review as this is not an adjoining parish.

iv) **Planning updates/issues:**

DCC Planning, DDDC – no matters, PDNPA – a query on ownership of a site has noted that this aspect is not normally taken into consideration in a planning application.

2048 Footpaths and Highways

Highways – the hole with cones and signs is still unrepaired - Report 714551596 to be chased with DCCllr. Our County Councillor has received no further updates on the VAS to date and forwarded a complaint to DDDC on early hedge cutting to Highways.

The closed road has increasing graffiti appearing on barriers, signs and posts. The hole in the wall reported to Highways is hidden by undergrowth currently. Dumping appears to be being carried out on NT land but only spotted by walkers due to its position.

2049 Reports and Decisions

- i. The Green / Parish assets – wall repairs were carried out prior to the village picnic and the mowing schedule altered to accommodate the late date.
- ii. Stanton Moor Solstice
2 nights of sound systems – not removed as in previous years, fire jugglers on the Moor with no PSPO enforcement, no ticketing of badly parked vehicles on the acknowledged normal emergency vehicle route over the top on Lees Road. This was combined with DCC advertising the this as a public event on one Network. The negative effect of the clearway on moving congestion to other points affecting locals with long delays and detours and no consultation with locals for yet another year will be conveyed to our County Councillor to pass to the Joint Service Emergency Planning team.
Thanks were expressed to the PDNPA Rangers for their efforts and clearing up afterwards.
- iii. PDNPA Minerals
An email to the Minerals Planner was agreed to query the new dry stone wall placed on the haul road entrance from Birchover without digging out the road to provide a foundation and appearing to impede site access.
- iv. Ecobat Resources Liaison meeting
The next Ecobat meeting is scheduled on 29th July but with no MD or EA attendance. The Woodland Plan presentation at noon on 29th July is to be queried by Council as to whether this is a public session to enable meaningful conversation on noise and light protection to prepare a plan that incorporates these aspects and whether further consultation is expected.
The Forestry Commission has logged our interest to be consulted on the Ecobat Woodland Plan when they receive it.
- v. DDDC PSPO Consultation
Council confirmed the continued requirement for a dog exclusion zone on The Green. DDDC proposals for PSPOs on all Moorland in the District are fully supported provided they are to be enforced. Records of incidents and an acknowledgement that Stanton Moor PSPO fire infringement is year round make it essential to enforce the PSPO.
